ADDITIONAL COSTS

The fee for service staff & barmen is **R100** per hour per service staff member

SET UP AND BREAKING DOWN FEE WILL BE R1500

This service includes the setup of reception tables and the ceremony area, as well as venue cleaning and the packing away of décor for later collection. Please note that this service does not include any décor setup or breakdown on the day of the event.

All décor items must be collected no later than two days after your event.

Unfortunately, we cannot accept responsibility for any décor left at the venue beyond this period.

(Please note, this does not include décor setup or breakdown on the day of the wedding.)

All décor must be collected no later than Monday at 10:00 AM following your wedding.

- Please note: a dance floor would need to be placed on the deck or in the reception area of the main restaurant.

Confirming Your Special Day

Booking & Payment Information

- A 25% deposit of the venue hire is required upon signing the contract to secure your booking. **Please note: no booking is confirmed until the deposit has been received.**
- Provisional bookings will be held for **five** days only.
- Each couple is allocated three dedicated planning meetings to guide and assist in creating your perfect day.
- Final confirmed numbers and planning details are to be submitted 10 working days before the wedding, with full payment due 7 days before the event.
- Any additional items arranged on the day will be charged on consumption to a master account, which must be settled at the conclusion of your event.

Our goal is to make the planning process seamless, allowing you to focus on enjoying every moment of your celebration.

TERMS & CONDITIONS

ALL BOOKINGS UNDER THIS AGREEMENT SHALL BE SUBJECT TO THE FOLLOWING TERMS AND CONDITIONS:

Terms and Conditions

All bookings under this agreement are subject to the following terms and conditions:

1. All invoices are due upon presentation. Any amounts not paid by the due date will accrue interest at 2% above the prime bank overdraft rate, as advised by Cassia Restaurant and Venue's bankers.
2. Should the function be cancelled:
 - All deposits are non-refundable.
 - Cancellations 31 days or more prior to the function date will incur a charge of 50% of the anticipated revenue.
 - Cancellations within 30 days of the function date will incur a charge of 100% of the anticipated revenue.
3. The anticipated number of guests must be provided 30 days prior to the function.
4. Final numbers and final payments are required 7 working days prior to the function and must be within no less than 20% of the initial contract. Cassia Restaurant and Venue will charge based on this final figure should there be a shortfall. The final confirmed numbers will be the final numbers catered for on the day.

TERMS & CONDITIONS

5. Deposit requirements will be determined at the discretion of Cassia Restaurant and Venue. Failure to pay the deposit by the agreed date will result in the booking being deemed cancelled.
6. Cassia Restaurant and Venue, nor its agents or employees, shall be liable for any damage or loss to goods brought onto the premises by the customer, employees, or guests, or for any injury or loss of life. The customer indemnifies and holds harmless Cassia Restaurant and Venue against any claims by third parties relating to this clause.
7. The customer is responsible for any damage caused to allocated rooms, furnishings, utensils, and equipment by any act or omission of the customer or their guests/employees.
8. Daytime functions must conclude by 16:00 and evening functions by 00:00. Unless a later time is specifically agreed in writing 7 days prior, and may incur an additional charge. **This is only applicable to daytime events**
9. The customer agrees to pay all legal fees on an attorney-and-own-client scale, including collection and tracing costs, arising from any claim or proceeding in connection with this agreement.
10. All menu tastings will be charged according to the pricing of the selected menu.
11. Conferences are scheduled between 08:00 and 17:00. **Extra time must be confirmed in advance.**
12. Any additional tables, chairs, cutlery, crockery, or glassware required for more than 120 guests will be rented at the customer's expense.
13. Cassia Restaurant & Tables at Nitida operate as a separate entity from Nitida Cellars; each operates independently.
